To transfer, administer, manage, give instructions, perform, implement and carry out any and all acts, rights and powers that the Principal as the lawful owner of the said Account(s) would ordinarily enjoy, and take any and all decisions and to sign any and all documents at its absolute discretion.
- 3. To prepare, sign, and file documents and/or forms with FBME, any authority, department, intermediary, operator and/or any other institution connected with its Account(s) situated anywhere in the world.
- 4. To appear before any Court or other tribunal in Cyprus, in the United Republic of Tanzania or any other jurisdiction as well as any other department or other authority (governmental or not) including but not limited to the FBME and/or the Central Bank of Cyprus and/or the Bank of Tanzania and/or the DIB and generally any authority, department, intermediary, operator and/or any other institution connected with the Account(s), situated anywhere in the world and file,

- **9.** To use, perform all and any other rights and authorities necessary to perform actions, set forth by this Power of Attorney, including, without limitation:
  - to appear before any state or private notary on behalf of the Principal and sign any and all necessary documents in connection with the exercise of powers granted under this Power of Attorney, or which are required or appear to be useful in the view of the Attorneyin-Law to implement the actions mentioned herein;

- 11. To act in any way deemed necessary for the duly execution of any act and/or of all acts as above mentioned, even if this act is not specifically mentioned in the present Power of Attorney.
